## **CHANGE OF BRANCH**

All those students who are going to enter B.Tech.  $3^{rd}$  semester in the session 2024-25 and have secured CGPA  $\geq 8.5$  at the end of second semester are eligible to be considered for change of branch. Interested students can apply for Branch change by filling up the attached proforma and submit the hard copy in the Academic Section by 15-06-2024. The request for branch change will be processed as per the rule/provisions.

The rule for Branch Change (for 2022-23 Batch onwards) approved in 99<sup>th</sup> meeting of Senate held on 19-07-2022 is as follow:-

- 1. Branch Change should be after the 2nd semester.
- 2. No Backlog and CGPA should be >= 8.5 after 1st year. In case of tie of CGPA, the All India JEE Main rank will be considered to break the tie.
- 3. Max of 10% of the sanction strength of the branch should be permitted to change the branch and the strength of branch should not fall below 80%.
- 4. Branch change will be only on the leftover seats.

The interested students should apply for branch change without waiting for the result. Student signatures are mandatory on the request form. Incomplete form will not be considered.

Please note that the preferences given once cannot be changed later. Also, after branch change allocation, student will continue in that discipline till completion of the degree. No application will be considered later for reverting back to the previous branch under any circumstances.
